

Authorizing The Chairman Of The Ulster County Legislature To Enter Into An Inter-Municipal Agreement For The Coordinated Children's Services School Placement Preventive Program With Ulster County Board Of Cooperative Educational Services (BOCES) – Department Of Social Services

Member of the Public Health and Social Services Committee, Craig V. Lopez, offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Social Services; and

WHEREAS, Section A3-4 (Y) and A2-6(A)(3) the Administrative Code provide that the Chairman of the Ulster County Legislature can, upon approval of the County Legislature, enter into an inter-municipal agreement on behalf of the County of Ulster; and

WHEREAS, pursuant to General Municipal Law, Section 119-n(a), the definition of a municipal corporation includes a board of cooperative educational services; and

WHEREAS, the Commissioner of the Ulster County Department of Social Services requests that the Chairman of the Ulster County Legislature be authorized to execute an inter-municipal agreement with the Ulster County Board Of Cooperative Educational Services (BOCES) in the amount of \$5,750.00 for the Coordinated Children's Services School Placement Preventive Program, for the term January 1, 2014 through December 31, 2014; and

WHEREAS, the Coordinated Children's Services School Placement Preventive Program will enroll fifteen high-risk students in the Ulster County BOCES after school program, who will be overseen by a case aide who will organize after-school activities, assist the students on a daily basis and in times of crisis, meet with their families, and facilitate collaboration with school and community service providers; now, therefore, be it
