

**Authorizing The Acquisition Of A Temporary Right-Of-Way Over Certain Real Property For The Purpose Of Replacing The Carmine Liberta Bridge On NYS Rt. 299 Over The Wallkill River – Department Of Public Works**

Referred to: The Public Works and Capital Projects Committee (Chairman Fabiano and Legislators Greene, Litts, Loughran, and Maloney)

Chairman of the Public Works and Capital Projects Committee, Dean J. Fabiano, and Deputy Chairman Peter M. Loughran offer the following:

WHEREAS, the Ulster County Legislature approved Resolution Nos. 152, 153 and 154 on March 15, 2016, amending Capital Project No. 458 and authorizing a bond resolution to provide funding for construction for the Project to replace the Carmine Liberta Bridge on NYS Rt. 299 over the Wallkill River (“the Project”); and

WHEREAS, the Project engineer has identified specific parcels of real property over which the County needs to acquire temporary easements in order to accomplish the Project; and

WHEREAS, owners of lands associated with those easements have been contacted, are aware of the project and amenable to a temporary easement without compensation to allow installation of a temporary bridge and associated access road to be removed upon completion and of the new bridge over the Wallkill; and

WHEREAS, the owners of these parcels identified below, are willing to convey the temporary easements to the County as follows:
