WHEREAS, the Commissioner of Public Works has been notified by the New York State Department of Transportation that additional funding for Ulster County in the amount of \$247,198.37 for the State fiscal year 2014-2015 is available; and

WHEREAS, the Commissioner of Public Works requests the 2014 Extreme Winter Recovery Appropriation account be created; and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of the members voting approval; and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval; now, therefore, be it
