Chairman of the Public Works and Capital Projects Committee, Dean J. Fabiano, and Deputy Chairman Peter M. Loughran offer the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works; and

WHEREAS, the Commissioner of Public Works has prepared a list of various repairs needed to the County pool located in New Paltz; and

WHEREAS, the project expenditures in the amount of \$425,000.00 were approved in the 2014 – 2019 Capital Program; and

WHEREAS, the project will provide necessary pool repairs to stop water loss, eliminate tripping hazards and bring the domestic and pool water systems up to current code; and

WHEREAS, recent extreme weather conditions accelerated deterioration of the pool's marcite lining, creating an increase in construction costs; and

WHEREAS, the additional construction costs are estimated to be \$75,000.00; and

WHEREAS, the Commissioner of Public Works requests that the 2014-2019 Capital Program be amended to reflect a change in cost from \$425,000.00 to \$500,000.00 for the New Paltz Pool Repairs; and

WHEREAS, the Commissioner of Public Works requests that Capital Project No. 414 be established for New Paltz Pool Repairs; now, therefore, be it

RESOLVED, that Capital Project No. 414 - New Paltz Pool Repairs, is hereby established and is funded in the amount of \$500,000.00; and, be it further
