WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works, and

WHEREAS, Ulster Prevention Council, a program of Family Services, Inc. has been a New York State Office of Alcoholism and Substance Abuse Services (OASAS) funded initiative in Ulster County for the past nine years; and

WHEREAS, Ulster Prevention Council had sought satellite office space that provides accessibility to the Ellenville/Wawarsing/Kerhonkson area to improve community outreach to and address the diverse needs of communities in the southern portion of Ulster County; and

WHEREAS, Family Services, Inc. has been leasing 108 square feet of office space from the County at Trudy Resnick Farber Center, 50 Center St., Ellenville, NY, and the lease agreement will expire June 30, 2015; and

WHEREAS, Family Services, Inc. wishes to continue leasing their office space for an additional one (1) year term commencing July 1, 2015 through June 30, 2016, at the annual cost of \$1,080.00, to include all utilities; and

WHEREAS, the Commissioner of Public Works has requested the County of Ulster to continue leasing office space at Trudy Resnick Farber Center, 50 Center Street, Ellenville, NY to Family Services, Inc. for a one (1) year term commencing July 1, 2015 through June 30, 2016, at an annual cost of \$1,080.00, with all utilities included; now, therefore be it
