

**Amending Capital Project No. 408 For The Purchase Of Highway Equipment – Amending The 2014 Capital Project Fund Budget – Department Of Public Works (Highways And Bridges)**

Chairman of the Public Works and Capital Projects Committee, Dean J. Fabiano, and Deputy Chairman Peter M. Loughran offer the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works; and

WHEREAS, in the approved 2014 – 2019 Capital Program, \$2,158,400.00 was recommended for the purchase of highway equipment for 2014; and

WHEREAS, pursuant to Resolution No. 136, dated April 15, 2014, the Ulster County Legislature approved the Commissioner of Public Works' request for \$1,321,200.00 for the purchase of highway equipment in 2014; and

WHEREAS, after the review of equipment needs for the County Highways and Bridges Program, the Commissioner has prepared a supplemental Highway Equipment List for year 2014 (which includes 4 dump trucks at a cost of \$160,000; 2 boom trucks at a cost of \$372,000; 1 tractor at a cost of \$138,000; 1 tire changing machine at a cost of \$35,000, 1 mechanic truck at a cost of \$60,200; 1 bobcat at a cost of \$40,000; and 1 Jeep Grand Cherokee at a cost of \$32,000) and requests approval for the remaining \$837,200.00 that had been approved in the current year's Capital Program; and

WHEREAS, it is now necessary to increase Capital Project No. 408 – Purchase of Highway Equipment for funding in the amount of \$837,200.00 for the year 2014; now, therefore be it

RESOLVED, that Capital Project No. 408 is hereby amended by increasing the total cost to \$2,158,400.00; and, be it further

RESOLVED, that the 2014 Capital Fund Budget is hereby amended as follows:
