

**Amending The 2014 Ulster County Budget By Appropriating Funds For Certain Contract Agencies**

Referred to: The Ways and Means Committee (Chairman Gerentine and Legislators Gregorius, Maio, Maloney, Provenzano, Rodriguez and Ronk)

Chairman of the Ways and Means Committee, Richard A. Gerentine, and Deputy Chairman Donald J. Gregorius offer the following:

WHEREAS, the County Executive developed the 2014 Ulster County Budget under unprecedented fiscal challenges caused by the New York State Assembly's failure to extend the County's authority to impose an additional 1% sales tax that has been in place for over 20 years; and

WHEREAS, the collection of sales tax is spread across all consumers, not only those that live in Ulster County, and is a way to offset the burden of property tax payers; and

WHEREAS, the 2014 Budget was developed utilizing projections relevant to two different scenarios: Ulster County being granted authority to continue the additional 1% sales tax levy on February 1, 2014, or March 1, 2014; and

WHEREAS, the County's authority to collect the additional 1% sales tax expired on December 1, 2013; and

WHEREAS, Ulster County Government desires to continue to provide essential services to its residents, some by utilizing various agencies that the County contracts with to provide the services; and

WHEREAS, in order to continue to provide seamless services to residents, the County Executive developed sequestration, a unique budgetary tool which provides for a progression of spending cuts should Ulster County's 1% sales tax not be extended; and

WHEREAS, the loss of the 1% additional sales tax equals a loss of revenue to Ulster County of over \$22 million for fiscal year 2014; and

WHEREAS, to partially address the potential massive loss of revenue, the adopted 2014 Ulster County Budget sequestered \$820,980.00, the funding necessary to contract with agencies to provide various services to Ulster County residents and placed the funds in Contingency; and

WHEREAS, the County is hopeful that its authority to levy the additional 1% sales tax will be reinstated by the New York State Senate and Assembly by February 1, 2014, in which event, no spending cuts associated with sequestration will be necessary; and

WHEREAS, Ulster County Government, in spite of the uncertainty present in the New York State Assembly, desires to continue to provide as many services as possible to its residents; and

WHEREAS, in order to provide services without interruption on January 1, 2014, it is necessary to transfer one-twelfth of the sequestered funds from Contingency to the relevant budgetary appropriation lines; now, therefore, be it

RESOLVED, that the 2014 Ulster County Budget is hereby amended as follows:

RESOLVED, that by providing certain services through the Department of Social Services the County is entitled to Federal Aid for the month of January in the amount of \$8,892.00 that is not otherwise budgeted, therefore the 2014 Ulster County Budget is hereby amended as follows:

RESOLVED, that in the event Ulster County's authority to levy the additional 1% sales tax is enacted by the New York State Legislature by February 1, 2014, then the Commissioner of Finance is hereby authorized to transfer the balance of the sequestered funds designated to pay the various contract agencies for their services into the appropriate budget lines; and, be it further

RESOLVED, that in the event Ulster County's authority to levy the additional 1% sales tax is not enacted by the New York State Legislature by March 1, 2014, then all of the contracts whose funds are sequestered shall be cancelled pursuant to the terms of each contract;
