1. Call the Meeting to Order:

Chairman Futerfas asked Commissioner Bischoff to read the sample letters to the editor he had drafted to inform the public about the work of the Commission.

Language for the Ballot Question is finalized in written form and read aloud by Chairman Futerfas. Commissioner Quigley moved to adopt this language.
