

Authorizing The Chairman Of The Ulster County Legislature To Execute An Agreement With New York State Division of Criminal Justice Services For A Federal Byrne JAG Grant To Purchase Seventeen Portable Radios – Amending The 2009 Ulster County Budget – Sheriff’s Office

The Criminal Justice and Safety Committee (Chairman Dart and Legislators Briggs, R.A. Parete, Zimet, Hansut, Maloney and Ronk) offers the following:

WHEREAS, the Sheriff has been awarded a grant from the New York State Division of Criminal Justice Services and has requested that the Chairman of the Ulster County Legislature be authorized to enter into a agreement for the purchase of seventeen portable radios for the criminal division, to improve radio communications and safety of the Sheriff’s Deputies in Ulster County, and

WHEREAS, this Contract No. T0632055, for a Federal Byrne JAG Grant No. BJ08632055, in the amount of \$10,000.00 for the period commencing October 1, 2008 and ending September 30, 2009, and

WHEREAS, the Criminal Justice and Safety Committee has met and approved said request with a majority of members voting approval, and

WHEREAS, the Ways and Means Committee has met and approved said request with a majority of members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an amendment to the agreement with the New York State Division of Criminal Justice Services, Contract No. T632055, to purchase seventeen portable radios, as funded by a Federal Byrne JAG Grant No. BJ08632055, in the amount of \$10,000.00, for the period commencing October 1, 2008 and ending September 30, 2009, in the form as filed with the Clerk of the Ulster County Legislature, or as modified with the approval of the County Attorney, and, be it further

RESOLVED, that the 2009 Ulster County Budget is hereby amended as follows:
