

Authorizing The Chairman Of The Ulster County Legislature To Execute An Agreement With The County Of Westchester To Provide For The Hudson Valley Green Talent Pipeline Transformation Plan – Department Of Employment And Training

Legislator Hector Rodriguez on behalf of the Economic Development, Housing, Planning and Transit Committee (Chairman Rodriguez and Legislators Bischoff, Loughran, Sheeley, Harris, Roberti and Terrizzi) offers the following:

WHEREAS, the Director of Employment and Training is requesting that an inter-municipal agreement be executed to provide services to the County of Westchester County, New York, for the Hudson Valley Green Talent Pipeline Project, and

WHEREAS, the Department of Employment and Training through its Workforce Investment Board will provide a staff person and educational resources to produce a Gap Analysis, Strategic Plan and Data Center Outline to identify business resources, and facilitate the promotion of Green industry and business in the Hudson Valley, and

WHEREAS, the County of Ulster will provide such services to the County of Westchester, for the period beginning May 1, 2008 and ending April 30, 2009, for a fee in the amount of \$44,000.00, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is authorized to execute an inter-municipal agreement with the County of Westchester, New York, to engage the services of the County of Ulster, to provide a Green Specialist to assist with the implementation of the Hudson Valley Green Talent Pipeline Transportation Plan during the period beginning May 1, 2008 and ending April 30, 2009, for a fee in the amount of \$44,000.00, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney's Office,
