WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County Department of Planning; and

WHEREAS, in accordance with Resolution No. 80 dated March 20, 2012, the County entered into a contract with the New York State Housing Trust Fund represented by the Office of Community Renewal, to accept and implement a New York State Main Street Grant in the amount of \$270,400.00 to assist businesses that suffered damages from Hurricane Irene and Tropical Storm Lee; and

WHEREAS, the County has funds remaining of \$52,305.43 that were not utilized in 2012 but will be drawn down to assist businesses in 2013; and

WHEREAS, the Department of Planning wishes to amend its 2013 budget in order to be able to account for these remaining funds; now, therefore, be it
