WHEREAS, Ulster County Area Transit budgeted funds in the 2006 Ulster County Area Transit Budget for the Bus Stop Shelter Program for the purchase of Bus Stop Shelters and landscaping for said purpose, and

WHEREAS, the funding for the landscaping portion has lapsed and it is necessary to restore said funding to continue the Ulster County Bus Stop Shelter Program, and

WHEREAS, the Director of Public Transit is requesting that such funding be restored to the current 2007 Ulster County Area Transit Budget for the purchase of landscaping for the Ulster County Bus Stop Shelter Program, and

WHEREAS, the Economic Development, Housing, Planning and Transit Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval.

RESOLVED, that this funding be restored to the Ulster County Area Transit to continue the Ulster County Bus Stop Shelter Program, and
