Legislators Richard A. Parete and Kenneth Ronk, Chairman and Deputy Chairman, respectively of the Law Enforcement and Public Safety Committee offer the following:

WHEREAS, the Ulster County Board of Cooperative Educational Services (BOCES) has requested a Deputy Sheriff be assigned as a School Resource Officer at the BOCES building located in Port Ewen, and

WHEREAS, BOCES will reimburse Ulster County 100% of the salary plus benefits of the Deputy Sheriff assigned as the School Resource Officer, and

WHEREAS, the cost of salary plus benefits totals \$68,958.00 and the reimbursement of this amount by BOCES to the County will be paid in equal quarterly installments, and

WHEREAS, the term of the agreement shall be July 1, 2012 through June 30, 2013, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to sign an agreement, and any amendments thereto, with the Ulster County Board of Cooperative Educational Services (BOCES) to provide a Deputy Sheriff to serve as a School Resource Officer to BOCES for the term July 1, 2012 through June 30, 2013, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
