AUTHORIZING THE CHAIRMAN OF THE ULSTER COUNTY LEGISLATURE TO ENTER INTO AGREEMENT WITH THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES FOR THE DOMESTIC INCIDENT PREPAREDNESS PROGRAM

The Criminal Justice / Public Safety / STOP DWI Committee (Chairman Meyer and Legislators Aiello, DePew, Every, Dart, Feldmann and Hyatt) offers the following:

WHEREAS, the New York State Division of Criminal Justice Services has awarded two grants to the Ulster County Sheriff's Office as part of the Domestic Incident Preparedness Program, and

WHEREAS, these grants (\$18,066.00 and \$40,500.00) are to be used for the purchase of equipment, supplies and training purposes for State homeland security, and

WHEREAS, the Criminal Justice/Public Safety/STOP DWI Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to enter into agreement with the New York State Division of Criminal Justice Services for the Domestic Incident Preparedness Program for the period of April 1, 2003 through March 31, 2005, and
