

Requesting A Matching Contribution Of Funds To The Ulster Regional Gang Enforcement Narcotics Team (URGENT) Confidential Investigations – Transfer Funds From Contingency – Amending The 2007 Ulster County Budget – Sheriff’s Office

The Criminal Justice and Safety Committee (Chairman Dart and Legislators Distel, Gregorius, R.A. Parete, Zimet, Aiello and Every) offers the following:

WHEREAS, pursuant to Resolution No. 87 dated March 14, 2007, budget lines for the newly formed Ulster Regional Gang Enforcement Narcotics Team (URGENT) were established, and

WHEREAS, \$22,500.00 has been received from other municipalities as a revenue and has been allocated to the expenditures for this program for the purchase of services, evidence and information, and

WHEREAS, the Ulster County Sheriff’s Office is the lead agency in a multi-jurisdictional drug and gang task force that is a combined effort of several agencies, and

WHEREAS, the Ulster County Sheriff is requesting that Ulster County provide a matching contribution to the Ulster Regional Gang Enforcement Narcotics Team (URGENT), and

WHEREAS, the Ulster County Sheriff is requesting \$22,500.00 be transferred from the Contingent Account to Confidential Investigations, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, the expenditure of these funds will be used as provided in Appendix F Guidelines For The Control And Use Of Confidential Funds as outlined by the New York State Division of Criminal Justice Services, and

FURTHER RESOLVED, that the 2007 Ulster County Budget is hereby amended as follows:
