

**Authorizing The Chairman Of The Ulster County Legislature To Execute An Agreement With New York State Division Of Criminal Justice Services – District Attorney’s Recruitment And Retention Program – Amending The 2007 Ulster County Budget – District Attorney**

The Criminal Justice and Safety Committee (Chairman Dart and Legislators Distel, Gregorius, R.A. Parete, Zimet, Aiello and Every) offers the following:

WHEREAS, the Ulster County District Attorney has requested that the Chairman of the Ulster County Legislature be authorized to execute an agreement, being said contract (T068612) in the amount of \$16,013.00, with the New York State Division of Criminal Justice Services (DCJS) to participate in the District Attorney’s Recruitment and Retention Program for the purpose of improving the recruitment and retention of qualified and experienced prosecutors through salary enhancement, and

WHEREAS, the District Attorney’s Recruitment and Retention Program, Project No. LG07-1052-D00 is Federal Pass-Thru State funded and will be administered over a one year period, starting January 1, 2007 through December 31, 2007, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement, being said contract (T068612) in the amount of \$16,013.00, with the New York State Division of Criminal Justice Services (DCJS) to participate in the District Attorney’s Recruitment and Retention Program for the period of January 1, 2007 through December 31, 2007, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and
