

Authorizing The Chairman Of The Ulster County Legislature To Execute A Simplified Renewal Agreement With The New York State Office Of Victim Services (Formerly New York State Crime Victims Board) – Department Of Probation

The Chairman of the Law Enforcement and Public Safety Committee Richard A. Parete, and Deputy Chairman Kenneth Ronk, offer the following:

WHEREAS, the Director of Probation has requested that the Chairman of the Ulster County Legislature be authorized to execute a Simplified Renewal Agreement pertaining to a current contract (NYS # C-501172) with the New York State Office of Victim Services (formerly the New York State Crime Victims Board) in the amount of \$240,702.00 which is funded 80% Federal (CFDA# 16.575) and 20% State; and

WHEREAS, the Chairman of the Legislature was authorized to enter into the current contract by Resolution 291, dated October 14, 2009; and

WHEREAS, the Crime Victims Assistance Program serves all victims of crime in Ulster County, providing counseling, accompanying victims to court, the hospital, and/or the police station, and working one-on-one with victims and their families, and

WHEREAS, the annual award amounts for the current multi-year term agreement are as follows: 2009-2010 \$237,489.00; 2010-2011 \$244,803.00; and 2011-2012 \$245,614.00; for a total three-year term award of \$727,906.00; and

WHEREAS, there is now available a one-year extension to the current contract for the period October 1, 2012 through September 30, 2013 in the amount of \$240,702.00, with an option for an additional one-year extension, making the term of this renewal October 1, 2009 to September 30, 2014; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute a Simplified Renewal Agreement, and any amendments thereto, pertaining to the current contract (NYS# C-501172) with the New York State Office of Victim Services (formerly the New York State Crime Victims Board), for the Crime Victims Assistance Program, for the term October 1, 2009 through September 30, 2014 as filed with the Clerk of the Ulster County Legislature, or as modified with the approval of the County Attorney,
