

**Authorizing The Chairman Of The Ulster County Legislature To Execute A Contract With Watch Systems, LLC (Offender-Watch Solution) – Amending The 2007 Ulster County Budget – Sheriff’s Office**

The Criminal Justice and Safety Committee (Chairman Dart and Legislators Distel, Gregorius, R.A. Parete, Zimet, Aiello and Every) offers the following:

WHEREAS, the Ulster County Sheriff has requested that the Chairman of the Ulster County Legislature be authorized to execute a contact, in the amount of \$8,000.00, with Watch Systems, LLC for Offender-Watch Solution software, and

WHEREAS, Watch Systems, LLC specializes in sex offender registration and community notification software and is the only fully integrated proven supplier of a demonstrable sex offender management software solution, and

WHEREAS, the fee for Offender-Watch Solution is \$7,000.00 per year and a one time \$1,000.00 per 1000 offender for initial expenses, and

WHEREAS, the Ulster County Sheriff requests \$8,000.00 be transferred from the Contingency Account to provide the funds for Offender-Watch Solution, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature be authorized to execute a contact, in the amount of \$8,000.00, with Watch Systems, LLC for Offender-Watch Solution software, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and
