WHEREAS, pursuant to Resolution No. 115, dated April 20, 2010, the Ulster County Legislature delegated the authority to the Special Task Force on the Golden Hill Health Care Center to study the policy decisions needed to examine the long term viability of the Golden Hill Health Care Facility, and

WHEREAS, a nine (9) member Special Task Force was created for this purpose, and

WHEREAS, this Special Task Force shall report back to the Ulster County Legislature upon the completion of the study with its full findings no later than September 1, 2010, and

WHEREAS, due to the volume and complexity of the materials to be reviewed, it is now necessary to request an extension of sixty (60) days for the submission of said report, and

WHEREAS, the Health and Human Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Governmental Services, Environmental and Administrative Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Special Task Force on the Golden Hill Health Care Center, is hereby authorized a sixty (60) day extension to November 1, 2010, to report its full findings to the Ulster County Legislature,
