WHEREAS, pursuant to Section C-11(O) of the Ulster County Charter and Section A2-5(15) of the Administrative Code, the Ulster County Legislature, shall have the power to approve the execution of certain contracts and amendments in the amount of \$50,000 or in excess of \$50,000 entered into by the County; and
