

**Authorizing The Chairman Of The Ulster County Legislature To Execute An Agreement And Any Amendments To The Agreement With The New York State Office Of Homeland Security – Law Enforcement Terrorism And Prevention Program (LETPP) – Sheriff’s Office**

The Criminal Justice and Safety Committee (Chairman Dart and Legislators Briggs, R.A. Parete, Zimet, Aiello, Hansut and Ronk) offers the following:

WHEREAS, the Ulster County Sheriff is requesting that the Chairman of the Ulster County Legislature be authorized to execute an agreement (Contract No. 835372) and any amendments to the agreement, with the New York State Office of Homeland Security, for the period July 1, 2007 through June 30, 2010, in the amount of \$132,000.00 to be used for Law Enforcement Terrorism and Prevention Program (LETPP) whose goal is to prevent and respond to terrorist attacks, minimize the danger and help recover from terrorist attacks, and

WHEREAS, the grant funds will be used to purchase four SUV’s to be used as emergency response incident command vehicles, and

WHEREAS, the grant requires no matching County dollars, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature be authorized to execute an agreement (Contract No. 835372) and any amendments to the agreement, with the New York State Office of Homeland Security, for the period July 1, 2007 through June 30, 2010, in the amount of \$132,000.00 to be used for Law Enforcement Terrorism and Prevention Program (LETPP), in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and
