

Requesting Transfer Of Funds From Contingent Account For Cornell Cooperative Extension in Ulster County – Amending The 2012 Ulster County Budget

Referred to: The Legislative Programs, Education and Community Services Committee (Chairman Harris and Legislators Donaldson, Gregorius, Lopez, and Wawro) and the Ways and Means Committee (Chairman Gerentine and Legislators Harris, Maio, Maloney, Gregorius, Provenzano, and Rodriguez)

Chairman of the Legislative Programs, Education and Community Services Committee, Wayne Harris, and Deputy Chairman David B. Donaldson offer the following:

WHEREAS, on December 5, 2011, the Ulster County Legislature voted unanimously to place \$53,000 into the contingency account to offset the possible moving expenses incurred by Cornell Cooperative Extension in Ulster County, and

WHEREAS, during the move, Cornell Cooperative Extension of Ulster County incurred expenses \$52,818.91, and

WHEREAS, this Legislative body recognized the move was required following the County's termination of the building lease at 10 Westbrook Lane, and

WHEREAS, the Executive Director of Cornell Cooperative Extension in Ulster County requests the Legislative Programs budget be increased by \$52,818.91 in order to cover the costs of Cornell Cooperative Extension's moving expenses, and

WHEREAS, the Legislative Programs, Education and Community Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the 2012 Ulster County Budget is hereby amended as follows:
