

Authorizing The Chairman Of The Ulster County Legislature To Execute An Inter-Municipal Agreement With The City Of Kingston – Youth Bureau

The Human Development and Personnel Committee (Chairman Gregorius and Legislators Loughran, Provenzano, Terpening, Hansut, Noonan and Terrizzi) offers the following:

WHEREAS, pursuant to Article III, Section A3-4(Y)(2), “the provision of facilities or the rendering of services by or for any other government must be approved by the County Legislature”, and

WHEREAS, the Ulster County Youth Bureau requests an inter-municipal agreement with the City of Kingston for the Environmental Education program, and

WHEREAS, the City of Kingston will provide two environmental instructors to train Ulster County youth, in-school and after school, in the Environmental Sciences, and

WHEREAS, the Director of the Youth Bureau and Chair of the Ulster County Youth Board join in requesting that the Chairman of the Ulster County Legislature be authorized to execute the inter-municipal agreement for the Environmental Education Program with the City of Kingston, and

WHEREAS, the Human Development and Personnel Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an inter-municipal agreement, and any amendments to said agreement, with the City of Kingston for the Environmental Education program for the operating year 2009, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,

and moves its adoption.
