Authorizing the Chairman Of The Ulster County Legislature To Execute An Agreement With The Rondout Valley Central School District To Provide A Deputy Sheriff As A School Resource Officer – Ulster County Sheriff

Referred to: The Law Enforcement and Public Safety Committee (Chairman Parete and Legislators Belfiglio, Briggs, Maio, and Ronk) and The Ways and Means Committee (Chairman Gerentine and Legislators Gregorius, Harris, Maio, Maloney, Provenzano and Rodriguez)

Chairman of the Law Enforcement and Public Safety Committee, Richard A. Parete, and Deputy Chairman Kenneth Ronk offer the following:

WHEREAS, the Rondout Valley Central School District (RVCSO) has requested a Deputy Sheriff be assigned as a School Resource Officer (SRO) at various locations within the District; and

WHEREAS, RVCSO will reimburse Ulster County 100% of the salary plus benefits of the Deputy Sheriff assigned as the School Resource Officer; and

WHEREAS, the cost of salary plus benefits of the Deputy totals \$68,806.31 and the County will invoice RVCSO for payment as per the contract; and

WHEREAS, the term of the agreement shall be September 1, 2013 through June 30, 2014; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to sign an agreement, and any amendments thereto, with the Rondout Valley Central School District to provide a Deputy Sheriff to serve as a School Resource Officer for the term September 1, 2013 through June 30, 2014, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, Counsel to the County Legislature, Chairman of the County Legislature, and the Chairman and Deputy Chairman of the Law Enforcement and Public Safety Committee,

and moves its adoption.
