

Adopting Introductory Local Law No. 11 Of 2007 (A Local Law To Amend Local Law Number 5 Of 2000 Requiring Checkout Accuracy And The Clear, Accurate And Adequate Display Of Selling Price), Hereinafter Known As Local Law Number 12 Of 2007

The Criminal Justice and Safety Committee (Chairman Dart and Legislators Distel, Gregorius, R.A. Parete, Zimet, Aiello and Every) offers the following:

WHEREAS, Resolution No. 187 dated May 9, 2007, set the date for Public Hearing on Introductory Local Law No. 11 Of 2007 (A Local Law To Amend Local Law Number 5 Of 2000 Requiring Checkout Accuracy And The Clear, Accurate And Adequate Display Of Selling Price), to be held on Wednesday, July 11, 2007 at 7:00 PM in the Legislative Chambers, Ulster County Office Building, 244 Fair Street, Kingston, New York, and

WHEREAS, said Public Hearing was held on Wednesday, July 11, 2007 at 7:00 PM, Ulster County Office Building, Kingston, New York, and

WHEREAS, said Public Hearing was duly advertised in the official newspapers of the County of Ulster together with a supplemental newspaper of the County of Ulster and posted on the signboard maintained by the Clerk of the Legislature situated in the Ulster County Office Building, and

WHEREAS, all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, and

WHEREAS, based upon the examination of the Ulster County Legislature, and pursuant to Part 617 of the implementary regulations pertaining to Article 8 of the State Environmental Quality Review Act (SEQRA), it has been determined that the adoption of this proposed Local Law constitutes a Type II action as defined under 6 NYCRR 617.5(c)(20) and (27) and does not require any determination or procedure under SEQRA, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Introductory Local Law herein is hereby adopted by the Ulster County Legislature, and hereinafter known as Local Law Number 12 of 2007,
