

Establishing Capital Project No. 301 For Elevator Repair County Office Building – Amending Capital Program 2007 – 2012

The Public Works Committee (Chairman Berardi and Legislators Bischoff, Cahill, Dart, Lomita, Stoeckeler, Fabiano, Felicello and McAfee) and the Ways and Means Committee (Chairman Lomita and Legislators Bartels, Berardi, Gregorius, Provenzano, Zimet, Cummings, Gerentine and Noonan) offer the following:

WHEREAS, an examination of the two hydraulic elevators located at the County Office Building, 244 Fair Street, Kingston, New York, was contracted by the Ulster County Department of Buildings and Grounds to determine if replacement of the elevators' hydraulic jack assembly was required, and

WHEREAS, Kevin H. Doherty and Associates, Inc., of West Nyack, New York, an independent contractor performed an in-depth examination of the hydraulic jack assemblies, elevator machine room, elevator pits, elevator hoistway enclosures, tops of hoistways enclosures and elevator cab enclosures, and

WHEREAS, the independent contractor has recommended that because the existing hydraulic jack assemblies of both elevators are the original hydraulic jack assemblies, in excess of 40 years old, and are of a single bottom design, both should be replaced immediately, and

WHEREAS, the Public Works Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Ulster County Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.15(c)(20) and (27) of the New York Code of Rules and Regulations (NYCRR) and within the meaning of Section 8-0109(2) of the New York Environmental Conservation Law as promulgation of regulations, rules, policies, procedures and legislative decisions in connection with continuing agency administration, management and information collection, and therefore, that pursuant to NYCRR 617.6(a)(1)(i), the County has not further responsibilities under SEQRA with respect to this matter, and
