WHEREAS, this position will be bonded and paid as a less than half time Account Clerk (Grade 6) at \$13.95 per hour effective October 8, 2008, and

WHEREAS, the Economic Development, Housing, Planning and Transit Committee Personnel Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Personnel Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.
