

Authorization By The Ulster County Legislature To Amend A 2006-2011 Contract Between The Ulster County Department Of Social Services And Family Of Woodstock, Inc.

Legislator Walter G. Frey, Jr., Chairman of the Health and Human Services Committee and Co-Sponsors: The Governmental Services, Environmental and Administrative Committee (Chairman Roberts and Legislators Belfiglio, Fabiano, Petit, Ronk, Richard Parete, Robert Parete, Rodriguez and Shapiro) and Multi-Sponsors: The Budget and Finance Committee (Chairman Gerentine and Legislators Bernardo, Frey, Hansut, Harris, Maio, Maloney, Gregorius, Lomita, Provenzano and Sheeley) offer the following:

WHEREAS, the Ulster County Department of Social Services has proposed that contract number C06-00489 with Family of Woodstock, Inc., be amended, and

WHEREAS, under this contract, Family of Woodstock, Inc., operates thirty-three housing units for chronically disabled individuals who have a history of homelessness or who would otherwise be homeless, and

WHEREAS, this program ordinarily is fully funded by HUD under a contract between HUD and UCDS (the sponsoring agency), and

WHEREAS, the purpose of this amendment is to ensure that Family of Woodstock has adequate funding through the full term of the current contract with HUD (five years, ending June, 2011), to continue operating at 33 housing units, thereby preventing an increase in Safety Net costs and a decrease by HUD of funded housing units when grant renewal takes place in June 2011, and

WHEREAS, the funding for this amendment will come from savings within the Ulster County Department of Social Services 2010 Budget, and therefore will not increase the County's 2010 appropriations, and

WHEREAS, the Governmental Services, Environmental and Administrative Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Ulster County Legislature hereby authorizes an amendment to the 2006 contract between the Ulster County Department of Social Services and Family of Woodstock, Inc., and, be it further
