

**Adopting Introductory Local Law No. 11 Of 2008 (A Local Law Adopting An Administrative Code For The County Of Ulster, State Of New York), Hereinafter Known As Local Law Number 10 Of 2008**

WHEREAS, Resolution No. 295, dated September 10, 2008, set the date for Public Hearing on Introductory Local Law No. 11 Of 2008 (A Local Law Adopting An Administrative Code For The County Of Ulster, State Of New York), to be held on Tuesday, October 7, 2008 at 6:45 PM in the Legislative Chambers, Ulster County Office Building, 244 Fair Street, Kingston, New York, and

WHEREAS, said Public Hearing was held on Tuesday, October 7, 2008 at 6:45 PM, Ulster County Office Building, Kingston, New York, and

WHEREAS, all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, and

WHEREAS, based upon the examination of the Ulster County Legislature, and pursuant to Part 617 of the implementary regulations pertaining to Article 8 of the State Environmental Quality Review Act (SEQRA), it has been determined that the adoption of this proposed Local Law constitutes a Type II action as defined under 6 NYCRR 617.5(c)(20) and (27) and does not require any determination or procedure under SEQRA, and

WHEREAS, the Laws and Rules Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Introductory Local Law herein is hereby adopted by the Ulster County Legislature, and hereinafter known as Local Law Number 10 of 2008, and moves its adoption.

No current or former County Legislator may be appointed **or confirmed** by the Ulster County Legislature or Chairman of the Legislature to any paid office or paid position of employment with the County of Ulster within one year after his or her service as a County Legislator has ended, with the exception of the Office of Commissioner of the Board of Elections.
