

**Authorizing The Chairman Of The Ulster County Legislature To Execute A Memorandum Of Agreement With The Ulster County Community College Faculty Association**

The Arts, Education, Tourism and Community Relations Committee (Chairman Zimet and Legislators Briggs, Gregorius, Sheeley, Cummings, Harris and Terrizzi) offers the following:

WHEREAS, the College Labor Attorney William Wallens and members of the executive staff have negotiated a two year collective bargaining agreement covering the period 9/1/2008 to 8/31/2010, with the Ulster County Community College Faculty Association and recommends the agreements to the Board of Trustees and the Ulster County Legislature, and

WHEREAS, the collective bargaining agreements have been reviewed by the Personnel, Educational Programs and Services Committee of the Board of Trustees, and

WHEREAS, the President has recommended affirmative action by the Board of Trustees on the collective bargaining agreements, and

WHEREAS, the Board of Trustees unanimously approved the agreement at its meeting on October 21, 2008, and

WHEREAS, the Ulster County Community College Faculty Association has ratified this agreement, and

WHEREAS, the contract results in an annual pay increase of 3.5% plus \$300.00 for year one and 3.5% plus \$300.00 for year two for full-time faculty, and

WHEREAS, the Arts, Education, Tourism and Community Relations Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Arts, Education, Tourism and Community Relations Committee does hereby recommend to the Ulster County Legislature, the approval of the collective bargaining agreement covering the period 9/1/2008 to 8/31/2010 between the County of Ulster and the Ulster County Community College Faculty Association, and
