

Authorizing The Chairman Of The Ulster County Legislature To Execute An Agreement With The New York State Office Of Temporary And Disability Assistance To Accept Funds For Community Solutions For Transportation (CSTVIII) Program – Temporary Assistance For Needy Families (TANF) – Social Services

WHEREAS, the Commissioner of Social Services requests that the Chairman of the Ulster County Legislature be authorized to execute an agreement in the amount of \$70,000.00, with the New York State Office of Temporary and Disability Assistance to accept funds for the Community Solutions for Transportation (CSTVIII) Program for the period July 1, 2007 to June 30, 2008, and

WHEREAS, Social Services administers these funds to help meet the transportation needs of individuals eligible for services under the Temporary Assistance for Needy Families (TANF) program who are employed or participating in other allowable activities, and

WHEREAS, the Human Development Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature be authorized to execute an agreement in the amount of \$70,000.00, with the New York State Office of Temporary and Disability Assistance to accept funds for the Community Solutions for Transportation (CSTVIII) Program for the period July 1, 2007 to June 30, 2008, in the form as filed with the Clerk of the Ulster County Legislature or modified with the approval of the County Attorney, and
