

**In Support Of New York State Assembly Bill No. A09191 And New York State Senate Bill No. S06311 To Amend Part G Chapter 56 Of The Laws Of 2011 Establishing The Hurricane Irene And Tropical Storm Lee Assessment Relief Act**

WHEREAS, the Ulster County Legislature adopted Resolution No. 16 dated January 23, 2012 entitled, "Adopting The Provisions Of The "Hurricane Irene And Tropical Storm Lee Assessment Relief Act," and

WHEREAS, Assembly Member Donna Lupardo and Senator John J. Bonacic have introduced NYS Assembly Bill No. A09191 and NYS Senate Bill No. S06311, which would amend Part G SS3 and 4, would add S5-a of Chapter 56 of the Laws of 2011, relating to the Hurricane Irene and Tropical Storm Lee assessment relief act, and

WHEREAS, the purpose of the bills is to amend Chapter 56 of the Laws of 2011, establishing the Hurricane Irene and Tropical Storm Lee Assessment Relief Act, in relation to extending the time for requesting aid and in relation to reduction of property assessments, and would enact a hold harmless provision for municipalities, now, therefore, be it

RESOLVED, that the Ulster County Legislature supports NYS Assembly Bill No. A09191 and NYS Senate Bill No. 06311 and urges the State Legislature to pass this legislation and the Governor of the State of New York to sign the bill into law, and, be it further
