

**Reclassifying Deputy Sheriff Sergeant Position To Deputy Sheriff Position And Deputy Sheriff Lieutenant Position To Deputy Sheriff Detective Lieutenant – Amending The 2008 Ulster County Budget – Sheriff’s Office**

WHEREAS, the Ulster County Sheriff has requested an amendment to the 2008 Ulster County Budget for the purpose of reclassifying one Deputy Sheriff Sergeant position to Deputy Sheriff position and one Deputy Sheriff Lieutenant position to Deputy Sheriff Detective Lieutenant position, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Personnel Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the following Deputy Sheriff Sergeant position (PC # 3110-1391) be reclassified to Deputy Sheriff position (PC # 3110-1391), and Deputy Sheriff Lieutenant position (PC# 3110-1295) be reclassified to Deputy Sheriff Detective Lieutenant position (PC # 3110-1295), and
