

**Reclassifying Positions – Amending The 2009 Ulster County Budget – Sheriff’s Office**

The Criminal Justice and Safety Committee (Chairman Dart and Legislators Briggs, R.A. Parete, Zimet, Hansut, Maloney and Ronk) offers the following:

WHEREAS, the Ulster County Sheriff has requested reclassification of positions to provide efficiency in jail staffing and operations, and

WHEREAS, the Ulster County Personnel Officer has reviewed the appropriate job class questionnaires submitted by the Ulster County Sheriff and has by Order and Determination #8317 dated February 12, 2009, reclassified the position of Corrections Corporal (Grade 11) (Full-time) to Corrections Officer (Grade 10), pending the anticipated retirement of the incumbent on March 7, 2009 and has by Order and Determination reclassified the encumbered position of Corrections Lieutenant (Grade 15) (Full-time) to Assistant Warden (Management) (Full-time) pending Legislative approval and subsequently has allocated such to the competitive class of the classified civil service; and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it
