WHEREAS, the New York State Office for the Aging (NYSOFA) is distributing cost of living adjustments (COLA's) for 2006/2007 program year to the Ulster County Office for the Aging, and

WHEREAS, the Director of the Ulster County Office for the Aging is requesting that the 2007 Ulster County Budget be amended to accept the additional funding in the amount of \$34,226.00, from the New York State Office for the Aging, and

WHEREAS, there is no increased County contribution associated with this transaction, and

WHEREAS, the Arts, Education, Tourism and Community Relations Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.
