

Authorizing The Reclassification Of Assistant District Attorney Positions - Amending The 2007 Ulster County Budget – District Attorney

The Criminal Justice and Safety Committee (Chairman Dart and Legislators Distel, Gregorius, R.A. Parete, Zimet, Aiello and Every) offers the following:

WHEREAS, the Ulster County District Attorney is authorized and empowered to employ Assistant District Attorneys as may be necessary to the extent allowed by New York State Civil Service Rules, and

WHEREAS, the Ulster County District Attorney has identified the need for a full-time, benefited, Assistant District Attorney, and

WHEREAS, there exists at this time two vacant positions of Assistant District Attorney, More-Than-Half-Time, with benefits, and

WHEREAS, the budgetary issues facing the County at this time requires that an accommodation be made to assure a Budget-neutral proposal to fulfill the needs of the District Attorney's Office, and

WHEREAS, the Ulster County District Attorney has requested that the vacant position of Assistant District Attorney (1165 1203) be reclassified from More-Than-Half-Time to Full-Time, and that the vacant position of Assistant District Attorney (1165-1056) be deleted , and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Personnel Committee has met and reviewed such request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.
