The TMP also supports the region's Congestion Management System program whereby traffic count data helps analyze and monitor regional (Dutchess, Orange and Ulster Counties) traffic volumes, trends and forecasts. Similarly, the purpose of the Travel Time Survey is to collect reliable Global Positioning System (GPS)-based travel time data on major roadways in the Mid-Hudson Valley Transportation Management Area (TMA) in support of the TMA's Congestion

#### Agenda Item 4a New Business (20 minutes)

Administrative Amendment to the UCTC Federal Fiscal Year (FFY) 2011-2015

Transportation Improvement Program (TIP) to Treat Utility Costs for Vehicle Fuel as a

Capital Maintenance Expense. The Consolidated and Further Continuing Appropriations Act, 2012 (Pub. L. 112–055) permits the Federal Transit Administration (FTA) to treat fuel costs for vehicle operations, including utility costs for the propulsion of electrical vehicles, as a capital maintenance item for grants made in FY 2012 under the Urbanized Area Formula Program, up to a total of \$100,000,000. FTA announced this provision and its implementation in the FTA Fiscal Year 2012 Notice of Apportionments, Allocations, and Program Information, published in the Federal Register on January 11, 2012 (Vol. 77, No. 7 1786–1856). Recipients are reminded that this provision does not provide any additional funding but rather how they may use a portion of their USA's Section 5307 program apportionment. Funds granted under this provision will be treated as an alternative use of the eligible recipient's formula funding

<u>Draft UCTC FFY 2011 Annual Federal Aid Obligation Report:</u> Federal regulations require an annual listing of bridge, highway and transit projects, including pedestrian and bicycle facilities, which Federal transportation funds have been obligated in the preceding year. An obligation is the U.S. Department of Transportation's legal commitment to pay the Federal share of a project's cost. Projects for which funds have been obligated are not necessarily initiated or completed in a given program year and the amount of the obligation in a single year will not necessarily equal the total cost of the project.

# Agenda Item 6 Announcements/Project Updates (10 minutes)

<u>Transit Development Plan (TDP):</u> Nelson/Nygaard Consulting Associates along with Fitzgerald & Halliday, Inc. are working as the consultants on the project. To date, three Technical Memorandums have been delivered to the Technical Advisory Committee along with a project Milestones/Deliverables Calendar and three project Newsletters. Technical Memorandum 3

was delivered in April and reviewed by the Technical Advisory Committee. The memo offers detailed analysis and assessment of each Citibus and UCAT route, including a "peers analysis" that compares local transit services with those from comparable areas across the region. Three community outreach meetings were held on April 18 and 19, including two open forum informational kiosks at Kingston Plaza and SUNY New Paltz as well as an evening public meeting held at Kingston City Hall. The next deliverable is Technical Memo 4: Assessment of Need and Identification and Evaluation of Alternatives, scheduled for delivery in May. The Draft and Final Implementation Plans are anticipated to be delivered in July. The project is presently on schedule for an August 2012 completion.

MHV TMA Travel Time Survey: The MHV TMA Travel Time Survey is complete. Data including survey videos, GIS information spreadsheet data have been received. The final report with the maps and the final presentation is available on the UCTC website at <a href="http://www.co.ulster.ny.us/planning/tdoc.html">http://www.co.ulster.ny.us/planning/tdoc.html</a>. These data are presently being compared with Priority Incident Location (PIL) data by staff in an effort to identify and measure correlations between highly-congested areas and frequent accident occurrence.

<u>Fourth Quarter Financial Report:</u> A Fourth Quarter Financial Report is enclosed for your information and reference. UCTC saw a slight decline in reimbursable expenses from the previous quarter, yet activity continues to be brisk due to two active projects. The fourth quarter of FY 2011-12 has approximately \$82,235 in reimbursable expenses. Contractual activity related to the Transit Development Plan and Traffic Monitoring Program continues to drive that activity. In the fourth quarter, Ulster County paid \$29,102 for work done on the Transit Development Plan and \$1,245 for work performed on the Traffic Monitoring Program. At the end of the fourth quarter, UCTC had expended 70% of its budget for operational expenses, and 45% for contractual activity.
