Marlborough Planning Board Intent to become Lead Agency for the Carriage House/Michael Rhodes project located on Route 44/55 in Milton, NY (SBL #95.2-1-37.0) Remove existing garage, improve entrance to DOT standards and erect a 12 bay auto storage with 4 bay auto repair commercial garage with 13 proposed parking spaces on 4.5 Acres. Erect one sign, plantings and general landscaping in C-2 Zoning Dist.
- f. New Paltz Planning Board SEQRA Notice of Intent to become Lead Agency Hampton Inn S. Putt Corners Road & Terwilliger Lane, Town of New Paltz, NY. (SBL#86.012-4-9.2) Applicant proposes to demolish an existing warehouse on 2.4 acre parcel and construct a three story hotel with a meeting room and related hotel amenities. The hotel will have 87 guest rooms and 96 parking spaces. A total of 54,948SF in the B-2 Zoning Dist. Will require service from Town water & sewer districts. The applicant also proposes to construct an off-site water line previously approved by UCDOH. The applicant seeks approval of a proposed building that conforms to the 40 foot height restriction but is also requesting review and approval of an alternative 3-story building that will require a height variance.
- g. NYSDEC Brownfield Cleanup Program Utility Platers, Inc. Building Interim Remedial Measures (IRM) work plan (Building Demolition) has been approved by NYSDEC & NYS Dept of Health for the facility known as Utility Platers, Inc at 416 Washington Avenue in Kingston, NY. Building demolition work relative to the Utility Platers site and the adjoining property (Kingston Diagnostics) will be performed concurrently with the IRM.
