At the end of the project, when FEMA deems the plan approvable, it is understood that our municipality will need to pass a resolution formally adopting the final plan if we are in agreement with said plan and wish to be deemed eligible by FEMA to apply for future funding for hazard mitigation projects. This resolution will be provided immediately to Ulster County Emergency Communications / Emergency Management for submittal to FEMA, who requires the resolution on file.
