• NYC Environmental Protection - Statement of Findings for the Extended New York City Watershed Land Acquisition Program – NYCDEP acting as lead agency issued a Notice of Completion of the Final Environmental Impact Statement (EIS) for the proposed Extended New York City Watershed Land Acquisition Program (LAP) on December 10, 2010. This project is classified as a Type I Action. The Final EIS summarizes and responds to comments received during the public review process.
