And I may as well mention now, we did do a release of funds, back in January or February. Duchess, Orange and Ulster acting as the transportation management area

released a call for projects, competitive funding awarded to designated recipients. We received a variety of proposals. There were five proposals submitted from throughout the region.

Two were for sidewalk projects which are eligible for funding if those projects are near transit facilities. These particular projects are deemed ineligible considering the way that they were proposed.

There were three remaining projects. One was from the MTA metro North for line upgrades and resiliency. The total project cost was \$200 million for the full Hudson line.

They requested \$15 million, which was the entirety of the application. The other submission was from UCAT, a total of \$4 million for bus electrification, equipment, and rolling stock, as well as for

conducting an engineering study for the construction of a new transit facility. Dutchess county public transit submitted \$4.2 million study, rather capital request for improvements to their facility.

So I apologize I don't have this ready for people to review, but it will be on the resolution in August.

The directors have recommended a partial Award for MTA in total of roughly \$4.2 million, full Award for UCAT of \$4 million, full award for Dutchess county.

So, you will see that in a resolution.

DD: Just so everyone understands, the source of this funds is 5307 from money that comes into the TMA. The TMA in terms of allocating 5307 money,

we generate a lot of that money comes from the private carriers, particularly from coach USA and Trailways and we set aside about 10% of that amounting to somewhere between \$2.5 to \$3.3 million a year.

And we set that aside for these types of projects and and the private carriers are also eligible. They did not submit.

And what ended up happening with respect to this is that we held back out the \$15 million we have available.

There's another allocation for federal fiscal year 2020, which is about \$3.3 million. We held that back so that's that that means it's in reserve.

And then we're waiting to see what happens with respect to the 2021 allocation as well. So, we should, even after we spend this money,

or allocate this money, we should have approximately available to us about \$6 million, which would again be unallocated and available for projects. And we usually let that build up

and then we release a call for projects. And the reason we do that is that transit transit demands are lumpy and big.

So, what ends up happening is is rather than allocated out we wait and we wait and then we make major capital investments or major changes in investments with respect to with respect to transit means.

In the past we funded buses for UCAT, we funded buses for Trailways, we funded buses for Dutchess County, we funded the ferry activity in Newburgh/Beacon, we funded Newburgh/Beacon ferry at the request for that.

I would say that Orange County generates a lot of this money but Orange County has a significant amount of transit funds available and

is kind enough to let the rest of the region use those use those funds. They have not asked for, they have not asked or participated in these awards.

Ulster County Transportation Council: So i'll leave it at that, I would say.

we're currently.. the CARES.. the American Recovery Act that was passed, the CARES act generated about \$85 million in transit funds into the TMA. That funding got fully allocated out to the private sector and to the public sector.

Trailways got about \$12 million of that money and we're still trying to track down

some of that fund. We're having discussions with Trailways with respect to the use of some of those funds.

They seem to be burning about \$4 million a year and operating costs

from that and we're having a constant discussion with respect to Trailways and CDTA,

which is the sponsoring entity for their trams grant with respect to the use of that funds.

And, what ended up happening under the American Recovery Act, according to the Federal Register there's another \$66 million coming into the TMA.

we don't know what the what the splits going to be as of yet because here's what happens part of the TMA extends into the State of New Jersey,

Typically, less than 10% that money goes to the State of New Jersey, but we don't know what those conversations are. We've had this in the past, where this has happened in the past.

And, and so, Sajaa could you give us a sense of where UCAT is in terms of ridership in terms of recovery. I think you made some surprising recovery as I recall.

beginning of the pandemic, we kind of suspended, a lot of our routes and as we scaled back up to almost full service by August and we were hovering around

anywhere between 25% of our usual ridership which is about half a million riders a year. We don't have a good statistic after we consolidated the City of Kingston unfortunately because

the pandemic hit before we hit our one year mark with the City of Kingston, but I would estimate it to be, you know all things being equal, around a half million riders a year.

And over the past, I would say, three months, we see 20% increase every month and we're hovering anywhere between on our various services, obviously, there are some differences.

We have our fixed route service that serves the Poughkeepsie train station and that's obviously falling behind, as is our New Paltz Loop because of

less students on campus obviously. But, for the most part, our ridership is back to 65 to 70% of where it was pre pandemic and the initial estimate provided by the MTA and Metro North was that it will take until 2025 to re

re up to where we were pre pandemic and I don't think that that will be the case. And, is this a good time for an announcement?
