**AMENDMENT TO THE UCTC FEDERAL FISCAL YEAR (FFY) 2014-2018
TRANSPORTATION IMPROVEMENT PROGRAM (TIP) TO ADD PIN 878049:
CONSTRUCTION OF PEDESTRIAN AND BICYCLE FACILITIES ON THE BROADWAY
CORRIDOR FROM BROADWAY AT ST. JAMES STREET TO FOXHALL AVENUE, CITY OF
KINGSTON.**

WHEREAS, Federal rules and regulations require that a Transportation Improvement Program (TIP) be developed and adopted by the designated Metropolitan Planning Organization; and

WHEREAS, the Ulster County Transportation Council (UCTC) has been officially designated as the Metropolitan Planning Organization for Ulster County and is authorized to amend the Transportation Improvement Program as needed to add or delete projects and modify costs, schedules and funding for federally funded projects; and

WHEREAS, the Ulster County Transportation Council (UCTC) has been designated by the Governor of the State of New York as the Metropolitan Planning Organizations (MPO) responsible, together with the State, for the comprehensive, continuing, and cooperative transportation planning processes for its respective Metropolitan Planning Area (MPA); and,

WHEREAS, Federal rules and regulations require that the urban transportation planning process include the cooperative development of a Transportation Improvement Program (TIP), consisting of a staged multi-year program of projects consistent with the long range transportation plan; and

WHEREAS, Federal surface transportation programs are the responsibility of the UCTC and authorized by the Moving Ahead for Progress in the 21st Century (MAP-21) Act; and

WHEREAS, the City of Kingston has been awarded Federal Transportation Enhancement Program funds and the New York State Department has requested to add these funds to the UCTC 2014-2018 TIP as detailed in Attachment 1; and

WHEREAS, these funds will be used to implement a number of pedestrian, bicycle and streetscape improvements along the Broadway corridor in the City of Kingston; and

WHEREAS, the findings of the *Kingston Broadway Corridor Conceptual Design Project ("Building a Better Broadway")*, included in the UCTC SFY2014/15 Unified Planning Work Program, will assist the City of Kingston in the selection and design of improvements to be implemented through this project; and

WHEREAS, the amount of federal funding programmed in each year of the TIP is based on available funding so as to maintain a fiscally-constrained program; and

WHEREAS, the UCTC, in cooperation with the New York State Department of Transportation (NYSDOT), has reviewed and documented compliance of its planning process with adopted *UCTC Operating Procedures*, UCTC public notice procedures, and all existing federal rules and regulations, including *The Moving Ahead for Progress in the 21st Century Act* (MAP-21) requirements.

NOW, THEREFORE BE IT RESOLVED, that the Ulster County Transportation Council adopts TIP Amendments to the UCTC 2014-2018 TIP as shown in Attachment 1; be it further

RESOLVED, that the Director of the Ulster County Transportation Council authorizes the Secretary to transmit the TIP Amendment to the New York State Department of Transportation (NYSDOT) and Federal Highway Administration (FHWA) for STIP approval.
