- Central Hudson –Would like to work with local municipalities and planning boards in identifying projects that may potentially affect or occur on or within transmission utility easements. Easement agreements or regulations may prohibit certain activities or require that these utility rights-of-way be kept clear of buildings, structures or other obstructions that may hinder access to the lines by Central Hudson repair and maintenance crews, or that may damage the electric and natural gas facilities. Central Hudson requests that planning boards refer applicants who are seeking approvals for subdivisions, site plans, building permits or other developments on properties which may be subject to these utility easements to Central Hudson's Special Services Division at 845-486-5258 to identify these transmission utility easements, provide information and answer any questions.

- NYSDEC NYS Superfund Program Saugerties Former Manufactured Gas Plant site The site is approximately ¾ acres located on Ferry Street approx. 300 ft south of the Esopus Creek & approx 3,000 ft west of the Hudson River. Supplemental Site Characterization activities are expected to begin on August 10, 2009 and continue for one to two weeks. Investigations include a soil vapor investigation, a surface and subsurface soil investigation, and a groundwater investigation. The goals of these activities are to fill data gaps remaining from the first phase of work in May 2009 to determine whether or not impacts from the former MGP exist and to determine whether or not MGP impacts have migrated off-site. NYSDEC encourages participation in the project comments and suggestions are welcome. Further documentation to be kept at: Saugerties Public Library, 91 Washington Ave, Saugerties & NYSDEC Region 3, 21 South Putt Corners Rd, New Paltz.
- ◆ Town of Ulster Town Board Lead agency request for coordinated SEQRA review for Millens Recycling Facility 923-942 Flatbush Rd (Route 32) Kingston, NY 39 acres in OM Zone. Construction of a recycling and transfer station for scrap metals. Project will include a 10,000 SF Office facility, 26,000 SF metal drop-off building, 26,000 SF building to house a metals shredding machine, 32,500 SF materials shipping building, 3,200 SF maintenance/storage building, 2,500 SF building to house UARC metal processing program and required roadways and infrastructure. The facility will be accepting and processing scrap metal for shipment to various steel and metal smelting facilities. The facility will accept, process and ship approximately 3,200 tons a month.
- ♦ Town of Lloyd Town Board Highland Square –NW Corner of Intersection of Rt 9W & Rt 299 Draft Scoping Document for a Draft Environmental Impact Statement (DEIS) Written comments accepted on the draft scope until August 10, 2009.
