## **Cleaner Greener Sustainable Communities Grant Program**

Regional Economic Development Plan – Assigned money to councils Council developed plan for regional economic strategy. Their main goal is to create jobs

### NYSERDA – CFA

9.6 Million Dollars Available. 10 Regions.

County was working with Dutchess, Ulster and Orange for HUD Sustainability Grant. The County Partnership was not successful and is similar to the current funding application available through NYSERDA.

Orange County and the Town of Greenberg are leading the application process. County Planning and DOE have pledged their support along with Mike Hein.

Public Staff can not be funded unless it's a new position. If the consortium is funded, they will have eight months to do a regional plan for seven counties. Baseline work will be a major part of the project.

Climate Smart Communities in Ulster are being asked to sign a letter. Both planners and implementers will need to be at the table and NYSERDA will hopefully allow for quick implementation. May be able to use Communities Baseline Data from Climate Smart Communities. Communities may be able to share model ordinances. Implementation is key and has become harder over time due to staffing issues. Inter-municipal collaborations

Municipal Govt's will most likely be serving on governance structure Planning Team – Working Groups will most likely be set up. Will work with not for profits, etc.

Many are discussing Streams after recent floods. Questions raised include:

- a. What to do with Streams?
- b. Leave them or disturb them?
- Funding available for Flood Buyout Program
- Esopus Creek Flood Control Issues Virginia asked questions
- Wetland Seminar was held last week, approximately 80 people attended. Climate Adaptation was a question that planning board members had. Planning Seminar could be co-sponsored with DEC. What idea topics are there.
- Policy guide for Sustainability What should planning board's be looking for. (Check with Kingston CAC on what they have...) Put on listsery requesting info.
