Beatrice Havranek, County Attorney, explained the history of the situation leading to the contract in discussion and stated that she has attempted to work with the state to amend the contract and that the State is not interested in negotiating the terms and conditions. Beatrice Havranek was able to work with the State

weekly. Additionally, Beatrice Havranek stated that some of the expenditures required within the terms and conditions of the contract are already incurred and would continue to be if the contract were rejected, such as plowing and heating. Committee members discussed the history of County paroles and stated a desire to offer parole services within Ulster County to avoid travel to outside Counties. Legislator Rodriguez questioned whether the County plans to demolish the building in contract. Discussion pursued on how demolition would be effected by the terms of the

contract.
