Attendees networked, shared their municipal committee's past successes and future goals, and heard presentations on relevant projects and resources from the Ulster County Department of the Environment, Cornell Cooperative Extension of Ulster County, the Hudson Valley Regional Council, and the Hudson River Watershed Alliance.

Successes



Ulster County municipalities saw many achievements in the last couple years, thanks in part to the support provided by environmental

committees and other local stakeholders! Here are just a few of the recent successes reported by committee members:

- The Town of Shandaken created their first Conservation Advisory Council
- Marbletown developed a 100% renewable action <u>plan</u>
- Hurley & New Paltz Town/Village completed community greenhouse gas inventories
- Hurley hosted a Green Expo and participated in the Partners for Climate Action Local Champions program
- The City of Kingston collaborated with Bard College to develop an air quality data collection program and citizen science network
- Five municipalities participated in the County's first Arbor Day tree planting program, planting dozens of trees in their communities



Challenges

Thank you for sharing your committee's obstacles and challenges – this information will support future resource development. Municipal environmental committees indicated the greatest need for support in the following areas:

- Streamlined information about external opportunities and resources
- Access to grant funding, which could be improved through (1) early notification of available funding opportunities (2) significant support with grant application development and submissions (3) reduced/streamlined administrative burdens (reporting requirements)
- Technical support with virtual meeting platforms, GIS mapping, and in creating accessible content (including catering to various languages and learning levels)
- Increased opportunities for best practice sharing between municipalities
- Identification of specific local laws, policies and plans that are applicable to small municipalities (towns/villages)
