Chair Mihm called the meeting to order at 4:08 PM.

Public Comment: Chair Mihm recognized Comptroller March Gallagher, who thanked the Commission Members for their work and expressed appreciation for their service.

Commission Member Rodriguez spoke in support of a proposal to restore the original 2007 Charter language that only persons incumbent in County government and approved by the County Legislature may be designated to any list of succession for possible service as Acting County Executive. Commission Member Rodriguez noted that Ulster County is the most liberal County with regard to legislative approval of deputy and acting county executives. Commission Member Tantillo noted that under the Commission's current direct ballot proposal, the Legislature would approve the succession plan and, in effect, the Acting County Executive.

Commission Member Tantillo expressed concern about the 3-day timeframe and noted her position that the notice should be county-wide. Commission Member Rodriguez noted that there would be a normal legal notice submitted to the County's official newspapers. Chair Mihm suggested the language "in 3 days or as soon as practicable thereafter." Commission Member Harris suggested that the notice should be "filed" within 3 days.

Commission Member Scott McCarthy joined the meeting at 4:28 PM.

Commission Members discussed whether to send the notice to the district, county-wide, or both. Commission Member Harris noted that each municipality has designated its own official newspaper and that local people look at local newspapers. Commission Members continued discussing different wording to be used in the proposed revision.

Commission Member Harris requested that the report reflect a recommendation from the majority of the Commission that the Commission convene more often than every ten years, but that due to feedback from the Legislature's Chair and the County Executive's Office, the Commission pulled it back to ten years. Commission Member McCarthy agreed and noted that future Commissions should get recommendations ahead of time. Deputy County Executive Johanna Contreras spoke in support of convening every ten years. Commission Member Donaldson spoke in support of every ten years, with the understanding that the Legislature or County Executive can convene the Commission at any time. Commission Member Simonofsky noted that the Commission already voted on these issues. Commission Member Harris asked that the issues be tabled for now until there is more information.

Commission Members discussed Matrix Item 106 (Legislature's proposal relating to departmental estimates). Comptroller Gallagher advised the Commission that the Legislature's proposal was covered in the Comptroller's proposed local law. Comptroller Gallagher advised the Commission that there are two issues with the filling of a vacancy of the Comptroller: (1) the vacancy is not decided by a primary, and (2) the Legislature overrides the Comptroller's successor. Commission Member Rodriguez noted that the Commission had held off on considering how to handle a vacancy of the Comptroller until after deciding how to handle a vacancy of the Executive. Commission Member Rodriguez requested draft language for filling a vacancy of the Comptroller that mirrors the proposed language approved by the Commission for filling a vacancy of the Executive.

Commission Members discussed Matrix Item 125 (Legislature's proposal to remove "shall devote full working time to the duties of the office" from C-77 relating to the Public Defender). First Assistant County Attorney Gumaer advised the Commission that Chair Bartels asked that his proposal be disregarded. Commission Members marked Matrix Item 125 as withdrawn.

Commission Members discussed Matrix Item 94 (Legislator Erner's proposal to amend C-77 to change "Consumer Fraud Bureau" to "Consumer Protection Bureau"). Assistant County Attorney Williams advised the Commission that there is no Consumer Fraud Bureau and that the Commission previously voted to remove references to a Consumer Fraud Bureau. Commission Members requested that Matrix Item 94 be removed from the matrix.
