#### 4. Old Business

I. Danskammer update

II. UC Climate Action Plan

Draft Plan was presented by Amanda LaValle. Any EMC member is invited to submit comments. In addition, a meeting at the UC Dept of Environment (17 Pearl St) was organized for Tuesday March 5<sup>th</sup> at 1pm for additional discussion.

## 6. Dept of the Environment Update

- Department of Environment has been charged with overseeing the implementation of the plastic bag ban. There is money budgeted for contractual services to support this effort. As of 2/27, firms were being interviewed to help with the education campaign around the ban. The ban goes into effect July 15<sup>th</sup>, 2019.
- II. The Department's Annual Report has been completed and will be shared with the EMC.

## 7. UC Legislature and Other Updates

- Legislative Report- Dave Haldeman attended committee meeting held on 2/7 (https://ulstercountyny.gov/legislature/committee/energy-and-environment) He noted there were a couple of amendments to the Plastic Bag law that were passed which included making the enforcement date January 2020.
- II. Other Updates
  - a. Dave noted he is continuing to reach out to Rosendale, Lloyd, and Marlborough for representatives to serve on the EMC
  - b. Composting Legislation Working Group- Margot B provided an update on this group which is helping to explore and support potential mandatory organic waste diversion legislation in Ulster County. Group is exploring legislation which would apply to entities that generate over 2 tons of organic waste per week of which there are 25 identified in Ulster County.   - c. Refrigerant Management Forum held 2/26. Emilie H. provided an update on this workshop as refrigerants are a powerful GHG and refrigerant management is widely viewed as one of the most effective "climate solutions" and is #1 on the drawdown list (<a href="https://www.drawdown.org/solutions/materials/refrigerant-management">https://www.drawdown.org/solutions/materials/refrigerant-management</a>). Local disposal and recycling is very important as is training of HVAC technicians to properly handle materials. There are opportunities for municipalities to better handle this material as well as grant funding through the NYS DEC.
  - d. Saugerties Go Green Fair will take place on May 4th
