3. Laura Cunningham, Stone Ridge: Ms. Cunningham noted state funding will be available wherever the facility is built, and the proposed site is not contiguous with SUNY Ulster dispelling the belief firefighters could walk from the college to the training facility.
4. Thomas Wanning, New Paltz: Mr. Wanning read entries from a book titled, “Violent American Century” authored by John Dowers, addressing why there are so many immigrants from Latin America.
