Periodic Compensation Review Committee Minutes for June 3, 2024 Meeting Held at 5:45pm: Community Room at Golden View, 52 Domenica Lane, Highland

Committee Members Present: Richard Gerentine Leon "Butch" Dener Sarah Fassett Kathleen Mihm

Other participants: Vanessa Shea - Confidential Secretary, Office of the County Executive

Chair Gerentine asked for a motion to call the meeting to order. Mr. Dener motioned and Ms. Fassett seconded the motion. With no one opposed, the meeting was called to order at 5:49 PM.

Chair Gerentine asked for a motion to approve the minutes from the May 22, 2024 meeting. Ms. Mihm motioned and Mr. Dener seconded the motion. With no one opposed, the minutes were adopted.

Chair Gerentine discussed the meeting materials, including information requested by Mr. Marmo regarding county jails. For comparison, Mr. Marmo wanted to know if Schenectady and Rensselaer Counties had county jails. Ms. Shea provided notes showing that the counties do have jails of similar sizes.

Chair Gerentine reviewed the chart of proposed salaries that were discussed in the previous meeting. He stated that in the recommendation, the committee can add a section noting that there is an on-going salary study for all county employees, and that the report is expected at the end of July. Mr. Dener asked how much the salary study cost; Ms. Shea responded that there was an RFP and that she will find the information on cost for him. Ms. Mihm stated that the committee can note in the report that, if possible, they will reconvene after the salary study report is released to adjust salary recommendations if needed. Ms. Shea stated that she will ask the County Attorney if a revision is possible after the committee submits their recommendations (due June 31, 2024 per Ulster County Charter Chapter C-110). Discussion ensued.

Ms. Mihm stated that she would like to discuss the option of increasing salaries for the proposed amount for each of the next two years (versus one increase that sets the salary for the next two years). Mr. Dener noted that he does not support that proposal for legislators, but supports it for the full-time positions (Clerk, Comptroller, Sheriff, Executive). Ms. Mihm noted that she supports the two-year increase for all titles being considered. Ms. Fassett also supported increases for each of the two years for all titles, noting that it would be beneficial in attracting people to serve in these roles. Chair Gerentine called Mr. Marmo on the telephone to ask his opinion of the proposal. Mr. Marmo stated that he is in agreement with the increases each year, noting that he supports bringing the salaries more in line with surrounding/comparable counties.

Chair Gerentine computed the proposed salaries with the increase happening each of the next two years:

Chair Gerentine noted that he would run the meeting. Ms. Mihm noted that all public comments would be considered and changes would be made to the Committee's recommendation if deemed necessary.

Chair Gerenitne asked for a motion to adjourn. Ms. Fassett motioned and Mr. Dener seconded the motion. With all in favor, the meeting was adjourned at 6:18 PM.
